This application is used to establish electricity service in individual name(s), regardless of property use (Business or residential). Service may be established as a joint account for up to two (2) persons sharing *the same* last name.

When applying for electrical service please included the following:

- Completed and Signed Application Form (Ensuring that all sections are filled in correctly)
- Valid Lease Agreement, Land Registry, or Land Transfer
- Copy of Valid Photo Identification (Driver's License, Passport or Voter's Identification)
- Security Deposit (Existing services: Assessed and charged based on 45 days estimated usage of the property to be occupied). Deposits for new residential services are based on square footage and number of bedrooms, and for new businesses based on data from the electrical load sheet.

Service connections are available Monday through Friday 8:30 am to 4:00 pm excluding Holidays, with connection of new services generally completed within four (4) to six (6) working days (time may vary based on conditions). Existing meter connections will be completed as needed during stated work hours. Customers are encouraged to visit our offices at least two (2) business days prior to required date of service.

In some cases contribution in aid of construction (CIAC) is required from customers, please see terms of service for details.
