0 kW - 5 kW	-\$0.175 per kWh	
5 kW – 10 kW	-\$0.15 per kWh	
0 kW – 5 kW (NHDT)	-\$0.28 per kWh (NHDT Only)	
0 kW – 100kW	-\$0.21 per kWh (Public Sector Only)	

The CORE rates are a Feed-in-Tariff Rate Structure (FIT Rate) as approved by the Utility Regulation and Competition Office (OfReg).
