^{*}Recovery of extraordinary COVID-19 costs, inclusive of deferred base rate revenues from June 1, 2020 – December 31, 2020, will take place via a \$0.0026 per kWh increase to listed Energy Charge rates for the period of January 1, 2021 through December 31, 2022.

Definitions:

- kWh kilowatt-hours (energy consumption)
- Sub-Meter a meter installed "downstream" of another meter, the "main meter," that measures the quantum of energy from the main meter consumed specifically for end-use as measured by the sub-meter.
- On-Peak as per the EV Rates Terms of Service, 8:00am 10:59pm, Monday through Friday
- Off-Peak as per the EV Rates Terms of Service, any time outside the defined On-Peak period.

Notes:

The above does not include the following for Rate EV:

- Charges for fuel costs and government fuel duty
- Charges for renewable energy purchased from Power Purchase Agreements and CORE/DER Agreements
- · Licence and regulatory fees

Rates RV and CV, as sub-metered services, will already include the above-listed charges, as applicable, via consumption and billing associated with the main electrical meter under Rate R and Rate C, respectively.

Customers with demand rates are only eligible to apply for Rate EV services – sub-metering is not allowed for these configurations.
